| May 25, 2021 | Board considers approval of redistricting software (<i>occurred</i>) |
| June 2021 | County launches redistricting website (<i>occurred</i>) |
| June 22, 2021 | Board meeting presentation on 2021 Redistricting Process (fulfills AB 849 requirement for one public hearing before the board draws a draft map or maps of the proposed supervisorial district boundaries) (<i>occurred</i>) |
| July – August 2021 | <p>Public Workshops and Meetings: Public meetings and workshops will be held to provide information on the redistricting process and receive comments including those regarding communities of interest.</p> <ul style="list-style-type: none"> • July: Hold virtual meeting with community-based organizations, government entities, media, and other trusted messengers to promote redistricting involvement by the public. (<i>occurred on July 15, 2021</i>) • July 21 & 28: OC Registrar of Voters (OC ROV) Redistricting Academy held on two days with four sessions. (<i>occurred</i>) • August: 5 proposed evening workshops – one in each supervisorial district to be coordinated through each Supervisorial district. (<i>occurred on August 3, 4, 5, 11, and 12</i>) |
| August 12, 2021 | Federal government <i>released</i> Legacy-format P.L. 94-171 Redistricting Data file; same data as P.L. 94-171 Redistricting Data but requires substantive additional processing for use. (<i>occurred</i>) |
| By September 16, 2021 | Federal government to formally release all P.L. 94-171 Redistricting Data, in the user-friendly format, to the public, states, the District of Columbia, and Puerto Rico. |
| September 20, 2021 | Statewide Database (SWDB) to <i>release</i> processed P.L. 94-171 Redistricting Data, adjusted for incarcerated individuals, to counties approximately 30 days after the release of the Legacy-format P.L. 94-171 Redistricting Data file. |

- September 28, 2021 Public Hearing at the Board meeting to receive public comment and to consider revised calendar and timeline.***
- September 29, 2021 Evening (6 p.m.) virtual public workshop to receive public comment and provide additional information on the Esri software and the public submission period.***
- October 1-15, 2021 Estimated public submission period of proposed maps based on P.L. 94-171 Redistricting Data adjusted for incarcerated individuals.
- By October 29, 2021 Draft maps posted on redistricting website.***
- November 2, 2021 Board meeting/Public Hearing to present draft map(s) and receive public comment.
- November 9, 2021 2nd Public Hearing regarding any possible map revisions and to receive public comment.
- November 16, 2021 Board meeting/Public Hearing to receive public comment and to select map for preparation of ordinance (if necessary).
- November 24–30, district for 2021 OC Public Works prepares census block data by supervisorial ordinance***
- December 7, 2021 Board reads and considers ordinance approving supervisorial district boundaries.***
- December 15, 2021 Statutory deadline for Board to approve redistricting ordinance maps for June 7, 2022 Primary Election.
- June 7, 2022 Primary Election with updated maps.
